## Contest Rules and Information

Miss Teen Fantasy Division:  
(Ages 13-14 by November 7, 2009)

1. Applications and Fees -Each contestant must complete the enclosed application, include a \$35.00 participation fee and return to Fantasy of Queens Pageant % Lisa Barrett, 897 FM 3013, Sealy, Texas 77474 or hand delivered to Wilson Engineering, 323 North Fowlkes St., Sealy, Texas 77474. Forms of payment accepted is cash or check made payable to Sealy Community Foundation. All applications along with participation fees must be postmarked or hand delivered no later than October 26, 2009. There will be no exceptions. You can contact Lisa at 979-885-8591 for more information.

2. Sponsor and Sash -All contestants must have a sponsor and a sash with the sponsor's name on the sash to wear for the personal interview and the Queens Pageant. Sashes can be obtained at Wittenburg Printing for a small fee. Be sure to have the correct spelling of the sponsor for Wittenburg Printing, they will not be liable for any misprints if you do not provide them with the proper spelling.

3. Eligibility - All contestants must be a resident of Austin County, Texas and/or enrolled in the Sealy, Bellville or Brazos Independent School Districts from the start of the current school year. There will be no exceptions. The 2008 & prior Miss Teen Fantasy title holders will not be eligible to compete in this division.

4. Rehearsal - There will be a mandatory rehearsal for all applicants. Anyone not attending the rehearsal will be disqualified and will not be refunded their participation fee. You will be notified of the rehearsal date and time after the deadline for the applications.

5. Pageant — a.) The first portion of the pageant is the personal interview. This will be with a minimum of 3 to a maximum of 5 judges, for approximately 7 minutes. During this time you will be asked questions that may be about yourself, current events or your opinion on a certain matter.

b.) The second portion of the pageant is the evening wear. You will wear a tea length or long formal gown and accessories. All dresses must be of good taste. Low cut or high split dresses are not acceptable.

c.) Each contestant will be asked a question by the Master of Ceremonies that she will have knowledge of after he/she has finished introducing and talking about the contestant's accomplishments.

d.) Talent is not part of our pageant and will not influence judging in any way.

6. Finalists - There will be 5 - 10 finalists selected, depending on the number of contestants participating in the pageant. Each finalist will select a question in which she has not seen prior to the pageant from a bowl and asked to read and answer the question. Finalists will be judged on their response. From the finalist a Queen and 4 Runner-ups will be chosen.

7. Miss Photogenic - This is an optional category. An additional \$5.00 fee per contestant will be charged and due at the same time of application along with the photograph. Only one photo will be allowed. The photograph must be no larger than a 5x7. The photographer will not be judged only the contestant.

8. Miss Congeniality - Contestants will vote in secret for Miss Congeniality. The contestant with the most votes will be Miss Congeniality. Voting will take place during the personal interviews.

9. Judging - Contestants will be judged on the following in Personal Interview and On-Stage:

a.) Poise and Personality - Attention is given to the contestant's poise, charm, carriage and the confidence by which she carries herself.

b.) Personal Appearance - Attention is given to the overall appearance and the contestant's sense of style. Scoring is not affected by the price of the clothing. Attire for the personal interview should be suitable for a teenage girl and of business like attire. This would include a semi-dressy dress, a business like suit, dressy slacks and blouse or sweater. No blue jeans, tank tops or tops revealing the mid-section. Attire for on-stage judging should be a tea-length or long formal dress (as stated in the pageant section).

c.) Self-Presentation - Attention is given to the overall image that is conveyed to the judges by the contestants. Girls are being judged at all times and should present themselves as such.

d.) Responsiveness to Questions - Attention is given to the contestant's communication skills and the substance of her answers.

10. Tie Breaker - If there should be a tie, the tabulators will take the tie to the judges to break.

11. Responsibilities of the Queen - The Queen is required to be present at the Fantasy of Lights events held on December 4th — 6th, 2009. She is also required to ride in the 2009 Fantasy of Lights Parade and in the 2010 Austin County Fair Parade. Parade entries will be submitted for the Queen, however she will be responsible for her own float/vehicle in the Fantasy of Lights Parade and the Austin County Fair parade.

12. General Rules — a.) Contestant must be of age (depending on each pageant category) by November 7, 2009.

b.) Contestant must be born a female, single, never married, nor given birth to a child.

c.) Contestant must be of good health and moral character.

d.) Pageant directors shall determine all decisions as to eligibility.

e.) All decisions of the judges are final and irrevocable.

f.) Any contestant showing unsportsmanlike behavior or conduct will be disqualified. No refunds will be issued.

g.) If for any reason a winner is disqualified, or elects not to participate, her title and all awards will be passed on to the 1<sup>st</sup> Runner-Up.

### Miss Fantasy Division:

(Ages 15-18 by November 7, 2009)

1. Applications and Fees - Each contestant must complete the enclosed application, include a \$35.00 participation fee and return to Fantasy of Queens Pageant % Lisa Barrett, 897 FM 3013, Sealy, Texas 77474 or hand delivered to Wilson Engineering, 323 North Fowlkes St., Sealy, Texas 77474. Forms of payment accepted is cash or check made payable to Sealy Community Foundation. All applications along with participation fees must be postmarked or hand delivered no later than October 26, 2009 There will be no exceptions. You can contact Lisa at 979-885-8591 for more information.

2. Sponsor and Sash -All contestants must have a sponsor and a sash with the sponsor's name on the sash to wear for the personal interview and the Queens Pageant. Sashes can be obtained at Wittenburg Printing for a small fee. Be sure to have the correct spelling of the sponsor for Wittenburg Printing, they will not be liable for any misprints if you do not provide them with the proper spelling.

3. Eligibility - All contestants must be a resident of Austin County, Texas and/or enrolled in the Sealy, Bellville or Brazos Independent School Districts from the start of the current school year. There will be no exceptions. The 2008 & prior Miss Fantasy title holders will not be eligible to compete in this division .

4. Rehearsal - There will be a mandatory rehearsal for all applicants. Anyone not attending the rehearsal will be disqualified and will not be refunded their participation fee. You will be notified of the rehearsal date and time after the deadline for the applications.

5. Pageant — a.) The first portion of the pageant is the personal interview. This will be with a minimum of 3 to a maximum of 5 judges, for approximately 7 minutes. During this time you will be asked questions that may be about yourself, current events or your opinion on a certain matter.

b.) The second portion of the pageant is the formal wear. You will wear a formal gown and accessories. All dresses must be long and of good taste. Low cut or high split dresses are not acceptable.

c.) Each contestant will be asked a question by the Master of Ceremonies that she will have knowledge of after he/she has finished introducing and talking about the contestant's accomplishments.

d.) Talent is not part of our pageant and will not influence judging in any way.

6. Finalists - There will be 5 - 10 finalists selected, depending on the number of contestants participating in the pageant. Each finalist will select a question in which she has not seen prior to the pageant from a bowl and

asked to read and answer the question. Finalists will be judged on their response. From the finalist, a Queen and 4 Runner-ups will be chosen.

7. Miss Photogenic - This is an optional category. An additional \$5.00 fee per contestant will be charged and due at the same time of application along with the photograph. Only one photo will be allowed. The photograph must be no larger than a 5x7. The photographer will not be judged only the contestant.

8. Miss Congeniality - Contestants will vote in secret for Miss Congeniality. The contestant with the most votes will be Miss Congeniality. Voting will take place during the personal interviews.

9. Judging - Contestants will be judged on the following in Personal Interview and On-Stage:

a.) Poise and Personality - Attention is given to the contestant's poise, charm, carriage and the confidence by which she carries herself.

b.) Personal Appearance - Attention is given to the overall appearance and the contestant's sense of style. Scoring is not affected by the price of the clothing.
