Location: Parking lot in front of Sealy City Hall (*food vendors only*)  
Around "Fantasy Park" – Atchison & Hardeman Streets  
(*All other vendors*)

Show Hours: 10:00 am to 5:00 pm (parade begins at 6:00 p.m.)  
*\*Read below for after hours sales opportunity.*

Booth Space: 12' Long x 12' Wide

Booth Fees: **\$75.00 with** electricity  
**\$50.00 without** electricity  
*Absolutely no refunds after November 15, 2009.*

**Craft show application deadline is November 25, 2009. Absolutely no refunds will be given after November 15, 2009. If application and fees are sent after November 15, 2009, no refund will be given.**

Set up time is between 8:00 am and 10:00 am. **All vehicles must be out of the craft show area no later than 9:45 am. Vendors may park along Second Street, shuttle service available.** All booths must be set up and manned by 10:00 am.

**FOOD VENDORS:** Food will be limited per food vendor. All food that you wish to serve must be listed on the application. You will be notified of the food(s) that you will be allowed to serve. On the day of the event, you must serve only the foods designated by the committee in order to participate in our show. Vendors are selected at our discretion.

**CRAFT VENDORS:** Items you will be selling must be listed on your application. If you have pictures of your products, please enclose one or two so we will have a better idea of what you will be bringing. Vendors are selected at our discretion.

**CANOPIES:** You must mark on the application if you will be using a canopy.

**\*AFTER HOURS SALES:** AFTER HOURS SALES OPPORTUNITY IS FROM 5:00 PM TO 8:30 PM (DURING THE PARADE). Please indicate on the application if you wish to stay after hours to sell to the large crowd that lines the streets during the parade. This will let us know where your booth space will be.
